All staff have completed first aid training through the Australian Red Cross.




# Site Information: Waterworks Reserve, Ridgeway

#### Condition of trails at the Waterworks Reserve

Walk from entrance to main sites: approx. 1km. Lightly sloped walks through wet and dry forests. Dry eucalypt forest walk: steep and loose under foot 200 meter section, optional steep stone staircase to lookout on Gentle Annie Falls, gentle down slope with some stone stairs and roots across pathways. 




# **Preparing for your Excursion**

#### Before your excursion, remember to:

- 1. Tune students to forest education activate their prior knowledge and gather/explore any questions they may have about forests
- 2. Complete the confirmation form which was emailed to you (as early as possible)
- 3. Use the Risk Assessment to inform your planning
- 4. Ensure students have appropriate clothing for the weather (e.g., pants, sneakers, hats).
- 5. Pack your school's First Aid Kit, sanitiser and anything else you will provide to the students
- 6. Remind adults and students to bring plenty of food and water
- 7. Have students remove anything unnecessary from their bags for easier carrying

### Supervision and Behaviour Management

For safety and identification purposes, it is recommended that students wear school uniform. Supervising teacher/s are responsible for duty of care. Teachers must stay with their class group at all times and manage student behaviour. Teachers are not permitted to leave the supervision of the group solely to the FEF staff.

Schools should take measures to bring extra teachers/staff to assist students who may need extra support.

It is recommended that classes with more than 25 students are accompanied by two adults (e.g., teacher and teacher assistant).

#### **Cancellations**

In the event of severe or adverse weather, the FEF staff may need to postpone or cancel your excursion. As our activities are outdoors with limited shelter, wet weather options are limited. All efforts will be made to reschedule the excursion.
